Statement 2 is correct: The second function of a Constitution is to specify who has the power to make decisions in a society. It decides how the government will be constituted. Example, Indian Constitution provisions for the formation of a Parliamentary form of government.

Statement 3 is correct: Third function of a Constitution is to set some limits to what a government can impose on its citizens. These limits are fundamental in the sense that the government may never trespass them. e.g. Fundamental Rights.
